

## What is this used for?

- Allows the client to send Earnest money QUICKLY & SECURELY
- Holds the earnest money in our escrow account until closing
- Comes in handy when client or agent is in a pinch:
  - Can't drop a check off?
  - Don't want to go through the hassle of having your bank wire the money?
  - Cheaper than wiring with most banks.

I hate having to be a check chaser!






- You, the agent, will send your client an email from Earnnest, requesting the allotted amount of money.

#### About Earnnest

Earnnest allows buyers to simply and securely pay earnest money directly to escrow holders. If your bank supports electronic transfer, the entire earnest money process should take a few minutes.







 First, client adds their name & phone number



- Review Details
  - Processing fee \$15
  - Confirm Identity
  - Verify Bank Account

\*Within the "Confirm Identity" portion, it will ask for the clients SS#







- If the client is using a RE/MAX Executive approved attorney, they will get refunded the \$15 fee at closing (it is credited on the invoice that Executive Title sends to the attorney)
- Once the client pays, our accounting department is notified. They then forward the info to the Admin of your office
- Proof of the deposit is then added to SkySlope by the Admin
- Agents will receive a notification of payment via Earnest

\*None of the client's info is saved in Earnnest OR given to the agent (The selling point = It's quick, easy, and SECURE!)

## **How does it work for the agent?**

- You, as the agent, initiate the process
- Go to <a href="https://earnnest.com/">https://earnnest.com/</a> and click "Agent" and then "Register"
- Earnest requires a 2-factor authentication, so it will immediately send you an email with a code to plug in.

You will need to know which escrow account the money needs to be sent to. This is centered on which office you are based out of. If you have questions regarding this, you can ask your Admin! A chart is provided here
